differentials, the American native white population had later marriage and lower marital fertility than blacks and foreign-born whites. Finally, both the United States and France also had begun their "nuptiality revolutions" to earlier and more extensive marriage before most of Europe. In all this, the demographic similarities between the United States and

France were striking, as were the contrasts with other contemporary nations undergoing the demographic transition. Although economic and social historians have not often regarded the United States and France as cases to be studied together, further comparisons of these two demographic "early starters" may prove very instructive.
